**Rules Section-**

You agree to abide by all membership rules/regulations of the club. You agree to comply with stated and customary rules for participation and use of equipment. You are responsible for all payments due and owing under this membership agreement, even if you do not use our facilities and services. However, in the event of

death or disability, liability for fees will terminate as of the date of death or disability. If our facility becomes temporarily unavailable due to an event such as fire, flood, loss of lease, or the like, we will extend your membership privileges for the period the facilities are unavailable.

**Late Fees:** You agree to pay a \$20.00 late fee if your monthly payment is received more than (10) DAYS PAST THE DUE DATE and/or any fee associated with returned payments or non-payments of dues. You agree to pay all costs of collection including agency fees, court or arbitration costs and reasonable attorney fees, which may be paid or incurred by the club. You agree that the club, The Edge Fitness Center or a third party, and their agents and assigns may send communications to you via email, including late payment notifications, solicitations and other correspondence. If your membership becomes delinquent past a 90-day period, your membership payments may be accelerated to the total amount of the membership due under this agreement.

**Membership Assumption of Risk and Release:** I understand the risk of injury from club activities and using any club equipment is significant, including the potential for permanent paralysis and death. I knowingly and freely assume all such risks, both known and unknown. I acknowledge and I assume all risks associated with using exercise equipment. I hereby release, the Edge Fitness Center, their respective owners, officers, affiliates, agents and employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct any sponsored event. With respect to any and all injury, disability, death or loss of damage to person or property whether arising from negligence of the releasees or otherwise, that may arise out of or in connection with my using the equipment or the facilities of the club or any incident that occurs while using the clubs facilities or engaging in club activities on or off the premises or otherwise related to my club meetings.

I agree that I understand how to use all of the equipment, as well as all exits and security devices. I understand the risks associated with using exercise equipment and exercising alone without the aid of a trainer or supervision and the presence of club staff on the premises. I hereby release and indemnify the The Edge Fitness Center, its officers, owners, agents, and employees, instructors and their insurers from and against any liability that may arise out of or in connection with my using any of the equipment or the facilities of the club or any incident occurs while using the clubs facilities or otherwise related to my club membership.

I expressly agree that this release is intended to be as broad and inclusive as permitted by the laws of this state and if a portion of this release is held invalid, the balance shall remain in full force and effect. This release shall apply to my heirs and assigns and in the case of a family membership to any minor included in my membership and on whose behalf I hereby sign as parent/guardian. I understand that the club is relying on this release in agreeing to enter into this agreement.

**I agree not to bring in any non-members or give my access card to anyone. If I do I agree that Edge Fitness may charge my account \$10.00 per person per time. (This also serves as a first warning, if you are coming in with other members please make sure they scan in so we do not accidentally charge your account)**

**Membership-** you have no right to assign or transfer your membership rights to any other person.

**Minors-** As parent and/or guardian of a minor, you hereby agree to be fully responsible for any and all actions, damages, injuries, or loss to property or person, performed by the minor with or without club supervision in the club.

**Security:** The Edge Fitness Center is under 24/7-camera surveillance but this system does not protect you from harm in or around the building premises. You must use caution when entering or leaving the building and you must bring to the attention to the club if you feel threatened or witness suspicious activity. Do not allow access to

individuals who knock on the door, this could put everyone at risk; if you do your membership may be terminated immediately with no refund of membership dues.

**Members Right To Cancel-**

**Early Cancellation Option-**If you wish to cancel this contract, you may cancel by delivering or mailing a written notice to the club. The notice must say that you do not wish to be bound by the contract and must be delivered or mailed before midnight of the seventh business day after you sign this contract. The notice must be delivered or mailed to: The Edge Fitness Center, 3501 8<sup>th</sup> Street South, Moorhead, MN 56560. If you cancel, you must return all club materials in order to stop auto payments. (Key Fobs...etc.)

**Medical Cancellation:** You may cancel this agreement for medical reasons. Your doctor must provide certification that your use of the Club facilities and services would impair your health.

**Relocation Cancellation:** You may cancel this agreement by written notice to The Edge Fitness Center if you permanently move your residences out of the area, you will need proof of relocation.

Cancellation is still required even after your contract date has past. After your contract date has passed your membership will continue on a month-to-month basis and will require 30 day written notice to The Edge Fitness Center of your wish to no longer continue your membership. If you terminate the agreement or stop the automatic debit arrangement in a manner not described in the agreement, then you may be responsible to the fitness center for breach of contract.

**Tanning: By signing this agreement you hereby assume all risks associated with The Edge Fitness Center tanning activity and hereby knowingly and voluntarily waive any and all claims and causes of action against The Edge Fitness Center, its employees, representatives and agents arising from any injuries sustained during or in connection with the use of these tanning beds.**
